

Privacy Notice

At Organto, we are committed to protecting and respecting your privacy. This policy, and any other documents we refer to in this policy, set out how we will use your personal information and who it will be shared with. Please read the following carefully.

By using our website, you signify your acceptance of this privacy policy, and you acknowledge the terms and conditions posted here. By submitting your information, you agree that it will be governed by our privacy policy.

What information do we collect about you?

- 1.1 We may collect and process the following data about you ("your information"):
- 1.1.1 information that you submit online via our site through making requests;

How will we use your information?

- 2.1 We use your information in the following ways:

- 2.1.2 for our internal purposes, such as research and analysis, quality control, detection of fraud, site performance, system administration, so that we can provide you with enhanced services (legitimate interests of Organto);

- 2.1.4 to create reports to assist with future marketing (legitimate interests of Organto);
- 2.1.5 to contact you to ask you for your view and opinions or to take part in surveys we complete from time to time, when you agree to participate (consent);
- 2.1.6 for complaint handling purposes (compliance with a legal obligation by Organto);
- 2.1.7 for answering questions and replying to feedback (legitimate interests of Organto).
- 2.2 We may monitor your use of our site, including your IP address, operating system and browser type, for system administration. This is statistical information about our users' browsing actions and patterns and does not identify any individual.
- 2.3 We only keep your information for as long as is necessary.

Marketing

4.1 We may contact you with information about our products and services from time to time, provided of course that you agree (consent).

Where do we transfer your information to?

- 5.1 Our site is hosted in Europe and we may transfer your information to, or store it in countries outside the European Economic Area ("EEA"). Such information may be processed by our service providers, suppliers and agents, who may be involved in the provision of hosting and support services (amongst other things).
- 5.2 We will only carry out such transfers where we are confident that the level of protection applied to your information will be similar as if it had remained within the EEA. For transfers outside of the Organto, we enter into 'model clause' data transfer agreements or rely on some other approved data transfer method to ensure adequate protection.
- 5.3 Please do not send us your information if you do not want it to be transferred to or stored outside the EEA. By providing your information to us, you agree and consent to us transferring to, and storing your information at, a destination that may be outside the EEA.

Who do we share your information with?

- 6.1 We may share your personal information with subsidiaries which are part of Organto.
- 6.2 We may have to share your personal information to comply with legal or regulatory requirements, or to enforce or apply our terms and conditions or any other agreements or to protect our rights, property or our customers etc. This may involve exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.
 6.3 We may also share your personal information with selected third parties for the purposes of website hosting, data analysis and customer support, amongst others.

How do we keep your information secure?

- 7.1 We will only disclose your personal information to third parties with whom we have a processing agreement or that have agreed in writing to provide an adequate level of protection for your personal information. In general, the third-party providers used by us will only collect, use and disclose your personal information to the extent necessary to allow them to perform the services they provide to us.
- 7.2 If you have a username, password or other login details which enable you to access certain parts of our site, you must not allow any other person to use them and must treat them as confidential. If you believe or suspect that someone else knows your login details you must contact us as soon as possible.
- 7.3 To protect your personal information, we take reasonable precautions and follow industry best practices to make sure it is not inappropriately lost, misused, accessed, disclosed, altered or destroyed.
- 7.4 Unfortunately, the transmission of information via the internet is not completely secure. Although we will apply our normal procedures and comply with legal requirements to protect your information, we cannot guarantee the security of your information transmitted to our site and any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.
